



Springett's Arcade Centenary Giveaway - Terms and Conditions

1. Promoter

The promoter of this promotion is Springett's Arcade Pty Ltd ACN: 000028437, located at Springett's Arcade, 37 Wingecarribee Street, Suite 107 Gallery Level Bowral NSW 2576 ("Promoter").

2. Promotion name

This promotion is known as the Springett's Arcade Centenary Giveaway ("Promotion").

3. Promotion overview

To celebrate 100 years of Springett's Arcade, the Promoter will hold a series of special event days honouring the birthdays of members of the founding Springett family.

On each Event Day, eligible attendees may claim one complimentary centenary gift, while stocks last, and enter a chance draw to win a \$100 Welby Garden Centre voucher.

4. Event Days

The Promotion will take place on the following Event Days:

Event times, locations and giveaway details may be promoted separately for each Event Day. Unless otherwise stated, each Event Day will commence at 10.30am at Springett's Arcade, Bowral.

5. Eligibility

Entry is open to Australian residents aged 18 years and over who attend Springett's Arcade in person on an Event Day.

Employees, contractors, directors and management of the Promoter, Gumnut Patisserie, Welby Garden Centre, Challenge Southern Highlands, and any agencies or businesses directly associated with the administration of the Promotion, as well as their immediate families, are not eligible to enter the prize draw.

6. How to participate

On each Event Day, the first eligible attendees may choose one of the following complimentary centenary gifts, subject to availability:

- one Gumnut Patisserie-made cupcake; or
- one limited-edition Springett's Arcade centenary tote bag.

There will be up to 100 cupcakes and 100 tote bags available on each Event Day. Gift selection is subject to availability at the time of claiming. Once either gift type has been exhausted, attendees may only select from the remaining available gift type.

Limit of one complimentary gift per person per Event Day.

7. How to enter the prize draw

To enter the prize draw on an Event Day, eligible attendees must:

1. attend Springett's Arcade in person on the relevant Event Day;
2. claim one complimentary centenary gift, while stocks last;
3. complete the official entry ticket with their required details;
4. place the completed entry ticket into the designated entry barrel; and
5. be following both the official **Springett's Arcade** and **Gumnut Patisserie** Facebook pages at the time the winner is verified.

No purchase is required to enter.

Limit of one prize draw entry per person per Event Day.

Incomplete, illegible, duplicate, altered, fraudulent or incorrectly submitted entries may be deemed invalid at the Promoter's discretion.

8. Prize

There will be one prize available on each Event Day:

- One \$100 Welby Garden Centre voucher.

The total prize pool across all five Event Days is \$500.

The prize is not transferable, exchangeable or redeemable for cash. Any ancillary costs associated with using the prize are the responsibility of the winner.

Use of the voucher may be subject to any terms and conditions imposed by Welby Garden Centre, including any expiry date or redemption conditions.

9. Draw and winner selection

Each Event Day will have a separate prize draw.

Entries for each Event Day will close once the Event Day giveaway has concluded, or at the time otherwise advertised by the Promoter.

One winner will be selected by random draw from all valid entries received for the relevant Event Day.

The draw for each Event Day will take place at Springett's Arcade, Bowral, within 5 business days after the relevant Event Day.

The Promoter's decision is final and no correspondence will be entered into.

10. Winner notification

The winner of each Event Day draw will be contacted using the details provided on their entry ticket within 5 business days of the relevant draw taking place.

Before the prize is awarded, the winner may be required to verify that they meet all eligibility requirements, including following both the Springett's Arcade and Gumnut Patisserie Facebook pages.

11. Unclaimed prizes and redraw

If a winner cannot be contacted, does not respond, is found to be ineligible, or does not claim the prize within 14 days of being notified, the Promoter may conduct a redraw from the remaining valid entries for that Event Day.

The redraw will take place at Springett's Arcade, Bowral, within a reasonable time after the original winner is deemed ineligible or the prize is deemed unclaimed.

12. Privacy

By entering the Promotion, entrants consent to the Promoter collecting and using their personal information for the purpose of administering the Promotion, verifying eligibility, contacting winners and awarding prizes.

Personal information collected may include an entrant's name, phone number, email address and any other details reasonably required to administer the Promotion.

By entering the Promotion, entrants acknowledge that their details will also be added to the Springett's Arcade email list for occasional news, events, offers and updates relating to Springett's Arcade. Entrants may unsubscribe from marketing communications at any time.

Entrants' personal information will not be sold or shared with third parties for their own marketing purposes.

This Promotion is in no way sponsored, endorsed, administered by or associated with Facebook or Meta.

By entering, entrants release Facebook and Meta from any liability associated with the Promotion.

Entrants acknowledge that any information provided in connection with the Promotion is provided to the Promoter and not to Facebook or Meta.

14. General conditions

The Promoter reserves the right to verify the validity of entries and entrants, including an entrant's identity, age, contact details and compliance with these Terms and Conditions.

The Promoter may disqualify any entrant who tampers with the entry process, submits an entry that is not in accordance with these Terms and Conditions, acts dishonestly, or engages in conduct that may damage the reputation or proper running of the Promotion.
